<u>Implementation of the WTO Agreement on the</u> Application of Sanitary and Phytosanitary Measures (SPS)

The Government of the Former Yugoslav Republic of Macedonia has submitted the following information on the implementation of the WTO Agreement on the Application of Sanitary and Phytosanitary Measures (SPS), with the request that it be circulated to members of the Working Party.

SPS measures regarding the human life and health are under the responsibility of the Ministry of Health. SPS measures regarding the animal and plant life or health are under the responsibility of the Ministry of Agriculture.

The Ministry of Agriculture, Forestry and Water Economy shall actively participate in the work of Codex Alimentarius, OIE, and IPPC – (as soon as the Republic of Macedonia becomes a member of the IPPC).
