## Revision

The Ministry of Economy and Trade of the Republic of Kazakhstan has submitted the following information with the request that it be circulated to members of the Working Party.

The legislative basis regulating the issues of sanitary and phytosanitary standards, animal health regulations and food safety regulations shall conform to SPS Agreement principles.  The legislative basis regulating the issues of sanitary and phytosanitary and devertinary includes the Law of the Republic of Kazakhstan 10 July 2002 No. 339-II "On veterinary" and the Law of the Republic of Kazakhstan 11 February 1999 No. 344-I "On Quarantine of Plants" (The Law of the Republic of Kazakhstan and additions are made into the Law of the Republic of Kazakhstan dated from February 2002 "On Quarantine of Plants" (The Law of the Republic of Kazakhstan 11 February 1999 No. 344-I)  In the given Laws the requirements in respect of the health of animals and safety of foodstuff are reflected according to the main principles of the SPS Agreement: transparency, risk assessment criteria, availability of the information, etc.  The existing standards in respect of veterinary science and plant quarantine are at the stage of study and harmonization according to the international requirements.
