The Ministry of Industry and Trade of the Republic of Kazakhstan has submitted the following Synoptic Table on Legislation of the Republic of Kazakhstan with the request that it be circulated to members of the Working Party.

The draft law contains a number of changes and amendments to the Laws of the Republic of Kazakhstan "On Standardization", and "On Certification". In particular, the draft law introduces: - certain conceptual corrections harmonized with international requirements and providing for the future transition to voluntary standards; - provisions on approval by the Gosstandart of translations of international, regional, national standards of foreign countries, as well as state standards into the national language and Russian aimed to ensure uniform interpretation of normative acts on standardization; - requirements to the establishment of products classification system; includes provisions on implementation of the products classification system in the Republic of Kazakhstan, and lists products to be covered by the system; and - changes to the certification system organizational structure; expands on normalization of activities of certification bodies and test centers, etc.	Under discussion in the Parliament of the Republic of Kazakhstan
