Note: Lao PDR has requested a transitional period until 2012 for the full implementation of the SPS Agreement based on technical assistance and national capacity.

Technical assistance on SPS is being elaborated under a multi-donor trust fund, the Trade Development Facility, under the Integrated Framework. The key components of the project are the strengthening of SPS capacity, focusing on:

- (i) Strengthening SPS institutional, legal and regulatory framework;
- (ii) Determining risk-based policies and control measures for SPS; and
- (iii) Strengthening the role of the private sector in the SPS regime.
