### Synoptic Table of Basic Russian Legislation in Selected Areas<sup>1</sup>

The Permanent Mission of the Russian Federation has submitted the following Synoptic Table of Basic Russian Legislation in Selected Areas.

#### Introductory Note

At the request of a number of Members of the Working Party the Russian Federation has prepared the following synoptic table of basic Russian legislation and other regulatory acts governing the areas covered by the main WTO Agreements. The Table is not meant to be exhaustive but to indicate the basic regulations governing the above areas and to make the Russian regime in the above areas more transparent.

In addition, the Table contains a number of significant draft laws aimed at bringing the Russian legislation into conformity with WTO rules and principles.

The majority of the legislation in the Table has already been submitted to the WTO Secretariat. The documents that have not been submitted are marked with an asterisk and will be provided to the Secretariat once they have been translated.
