The Government of Timor-Leste is committed to the introduction of new standards, animal health regulations and food safety regulations in conformity with the SPS Agreement principles, as well as to the adoption of SPS-related laws in conformity with the Agreement and based on the international standards, guidelines and recommendations developed by the Codex Alimentarius Commission, World Animal Health Organization (OIE), and the International Plant Protection Convention (IPPC). In this context, the Government of Timor-Leste has developed new SPS-related legislation: draft Decree-Laws on "Animal Health and Quarantine" and "Plant Health and Quarantine" (provided to the Working Party ¹) that are based on the standards referred above. The Government is committed to enact these Decree-Laws in 2022. In terms of implementation, the Government of Timor-Leste would like to request for a 5-year implementation period (until 2027). Article 18(c)(d) of the draft Decree-Law on "Animal Health and Quarantine" provides that animal health measures approved by the Veterinary Authority shall be necessary to achieve Timor-Leste appropriate level of animal health protection and be the least-trade restrictive option that achieves this.

The Government of Timor-Leste will be fully committed to base regulations governing animal and plant health and food safety on scientific evidence.

Article 25(a) of the draft Decree-Law on "Animal Health and Quarantine" authorizes the Veterinary Authority to negotiate bilateral and multilateral agreements, for the evaluation, and where feasible, the acceptance of alternative animal health measures proposed by an exporting country's Veterinary Authority as being equivalent to the animal health measures required by the Timor-Leste Veterinary Authority. As Timor-Leste seeks a transition period to build capacity and achieve full compliance with the SPS Agreement by 2027, effort will be made to achieve full consistency with the SPS Agreement (including Article 4) and the relevant decisions of the WTO SPS Committee on Equivalence.
