Action Plan for the Implementation of the WTO Agreement on the Application of Sanitary and Phytosanitary Measures (SPS)

Revision

The Government of the Socialist Republic of Viet Nam has submitted the following Action Plan for the Implementation of the WTO Agreement on the Application of Sanitary and Phytosanitary Measures (SPS) for 2003 to 2004, with the request that it be circulated to the members of the Working Party.

Following the comments raised by Working Party members, Viet Nam would also like to make changes to the Action Plan for Implementing the SPS Agreement for 2002-2003 (WT/ACC/VNM/11/Rev.1) as follows:

- Transparency obligation in Boxes 3 and 10 are to be moved to Box 2;
- Box 3 should be rewritten as "Inspection measures of Viet Nam are only applied to the extent necessary with a view to protecting human, animal and plant resources of Viet Nam".

	The Ordinance on Plan Protection and Quarantine and Rules on Plan Quarantine (amended) are already issued on 25 July 2001. Viet Nam is re-checking all legal documentation for modification and amendment to be conformed with the Ordinance and Rules.	Issuing specification and standards on phytosanitary to well carry out the new Ordinance and Rules conforming with SPS Agreement Working together with relevant ministries to establish enquiry points for SPS information provision.
