#### OVERVIEW OF THE STANDARDS AND TRADE DEVELOPMENT FACILITY

Note by the Secretariat<sup>1</sup>

#### I. INTRODUCTION

- 1. The Standards and Trade Development Facility (STDF) is a global programme in capacity building and technical cooperation established by the Food and Agriculture Organization of the United Nations (FAO), the World Bank, the World Organization for Animal Health (OIE), the World Health Organization (WHO) and the World Trade Organization (WTO).
- 2. The STDF grew out of a joint communiqué issued by the Heads of FAO, OIE, World Bank, WHO and WTO at the Doha Ministerial Conference in November 2001. In the communiqué, the five organizations agreed to jointly explore new technical and financial mechanisms for coordination and resource mobilization. They also agreed to build alliances between standard setting bodies and implementing and financing agencies so as to ensure the most effective use of technical and financial resources. From this communiqué, the STDF was born in 2002.
- 3. The STDF acts both as a coordinating and a financing mechanism. Its strategic aims are:
- to assist developing countries in particular Least-Developed Countries (LDCs)<sup>2</sup> and Other Low Income Economies (OLIEs)<sup>3</sup> enhance their expertise and capacity to analyze and to implement international sanitary and phytosanitary (SPS) standards, so improving their human, animal and plant health situation, and thus ability to gain and maintain market access; and
- to act as a vehicle for coordination among technical cooperation providers, the mobilization of funds, the exchange of experience and the dissemination of good practice in relation to the provision and receipt of SPS-related technical cooperation.

#### II. COORDINATION

4. As a coordinating mechanism, the STDF is a forum for information sharing on past, present and planned SPS-related technical cooperation activities. Central to the STDF's coordination role is reporting on technical cooperation provided or planned, the sharing of project and programme implementation experience and the dissemination of good practice in relation to both the provision and receipt of SPS-related technical cooperation. A further component of STDF's coordination function is to ensure that projects and other proposed initiatives do not duplicate past, present or planned technical cooperation activities. The STDF coordination role has been reinforced in the recently adopted Medium Term Strategy.

#### III. FUNDING

- 5. As a financing mechanism, two forms of grants are available. Project Preparation Grants (PPGs) up to a maximum of US\$20,000 are available for proposal development. PPGs are a key mechanism for STDF programme development as they help overcome constraints faced by developing countries in the identification of their SPS needs and their articulation into sustainable projects. PPGs are also a mechanism for ensuring synergy with other ongoing initiatives in particular the Enhanced Integrated Framework for Trade-Related Technical Assistance to Least-Developed Countries (EIF).<sup>4</sup>
- 6. Project grants aim to address underlying issues of SPS capacity building in beneficiary countries. Ideally, projects should be innovative, preventative and/or pilot projects which may be replicated by other donors. Projects may aim to address gaps in SPS information or training materials, or to improve coordination. Projects which aim at regional solutions to SPS concerns are particularly encouraged. Financing up to 90 per cent of project total cost is available for private and public organizations in LDCs and OLIEs. The STDF funds projects that typically range from to US\$300,000 to US\$600,000.
- 7. The STDF has a target to devote 40 per cent of grant resources to LDCs and OLIEs. To achieve this target, the STDF continues to build synergies with other technical cooperation programmes. The STDF Secretariat works closely with colleagues in the EIF Executive Secretariat to assist in the identification of SPS, the elaboration of Diagnostic Trade Integration Studies (DTIS) and the development of project grants. To date, the number of LDC-specific projects approved by the STDF stands at 10 projects and 17 PPGs (out of a total of 23 projects and 23 PPGs). Further details on these projects and project preparation grants can be found in Annex 1.

#### IV. MEDIUM TERM STRATEGY (2007-2011)

- 8. A new STDF Medium Term Strategy (2007-2011) was adopted in December 2006.<sup>5</sup> This strategy places emphasis on the STDF as a vehicle for coordination among technical cooperation providers, for the exchange of experience, and for the dissemination of good practice in the provision and receipt of SPS-related technical cooperation. The STDF continues to provide funding for projects, but with more focus on project development through the use of PPGs and on the mobilization of donors to fund resultant projects. It will also aim to mobilize financial resources for project funding within the general donor community, rather than relying exclusively on the STDF's limited budgetary funds.
- 9. As part of its coordination function, the STDF is researching the supply and receipt of SPS-related technical cooperation in three regions. The regions surveyed will be Central America<sup>6</sup>, the East African Community (EAC)<sup>7</sup> and a sub-group of ASEAN countries.<sup>8</sup> This research feeds into the broader Aid for Trade<sup>9</sup> initiative and should provide valuable insights, not just with regard to the future provision of SPS-related cooperation, but with respect to the provision of technical cooperation in other specific subject areas. Results of STDF research on SPS "demand" and "supply" response will be presented at the regional Aid for Trade events in Asia, Africa and Latin America planned for September and October 2007.

- 10. The Aid for Trade events will be followed up with further research and coordination between countries in each region to examine the effectiveness of past SPS-related technical cooperation activities, the identification of good practice which can be replicated in future cooperation projects or programmes and how ongoing needs can be prioritized. This research will culminate in regional consultations between donors, beneficiaries and organizations engaged in the delivery of SPS-related technical cooperation in 2008.
- 11. The intention is to repeat this exercise across other regions during the life of the Medium Term Strategy (2007-11). In addition to further regional consultations, at least one global level workshop/consultation will be organized to ensure that lessons learnt from the regional consultations can be disseminated more widely.
