FREE TRADE AGREEMENT BETWEEN TURKEY AND THE FORMER YUGOSLAV REPUBLIC OF MACEDONIA

Communication by Turkey

Revision

I. BACKGROUND INFORMATION ON THE AGREEMENT

1. Membership, dates of signature, ratification and entry into force

The Parties to the Agreement are the Republic of Turkey and the Republic of Macedonia. The Agreement applies in respect of the territory to which the customs laws of Turkey and Macedonia are applicable respectively.

The Free Trade Area Agreement between Turkey and Macedonia was signed on 7 September 1999 in Ankara and entered into force on 1 September 2000 after the completion of the legal internal ratification procedures of the two Parties.

2. Type of Agreement

The Agreement establishes a free trade area in conformity with the definition set out in Article XXIV:8 (b) of WTO/GATT 1994.

3. Scope

The free-trade area established by this Agreement provides the framework for future trade relations between Turkey and Macedonia.

The Free Trade Area Agreement covers all trade in industrial products (HS Chapter 25-97) and a number of agricultural, processed agricultural and fishery products. In accordance with the evolutionary clause contained in the Agreement Parties agreed to further develop the relation established by this Agreement by extending them to fields not covered thereby.

With the entry into force of the Agreement, customs duties and other restrictive regulations of commerce on industrial and certain agricultural products were abolished or decreased, thus meeting the requirement of Article XXIV in respect of the principle of "covering substantially all trade".

In order to ensure the proper functioning of the free-trade area, the Agreement contains provisions, *inter alia*, on State-aid, State monopolies, competition, public procurement and protection of intellectual industrial and commercial property.

4. Trade Data

II. TRADE PROVISIONS

1. Import restrictions

All customs duties and charges having equivalent effect on imports of industrial products except for those classified as sensitive, were abolished by the entry into force of the Agreement. As for the sensitive products, customs duties and charges having equivalent effect will be gradually eliminated by the year 2008. There are also annual ceilings fixed for the imports of several industrial Macedonian originating products into Turkey.

The Parties will not introduce new quantitative restrictions and measures having equivalent effect on imports and agreed upon the elimination of all quantitative restrictions on imports and measures having equivalent effect upon the entry into force of the Agreement with the exception of textile products which are covered by the Memorandum of Understanding between the Government of Macedonia and the Government of Turkey signed on 27 October 1997.

Turkey and Macedonia granted each other preferential market access for a number of agricultural products.

2. Export restrictions

Under Article 6, prohibition of new customs duty or charges having equivalent effect on exports between the Parties is envisaged. Moreover all existing duties and charges having equivalent effect on exports applied to industrial products are abolished with the entry into force of the Agreement.

3. Rules of origin

The rules of origin on trade between Turkey and Macedonia, defined in Protocol 2 of the Agreement, are based on the sufficient working or processing criteria. In general, origin is conferred when:

- the good is wholly obtained or produced in the territory of a Party;
- each of the non-originating materials used in the production of the good undergoes an applicable change in tariff classification set out in the specific rule for that good, and the good satisfies any other applicable requirement set out in that rule, as a result of production occurring entirely in the territory of one or both of the Parties;
- the good is produced entirely in the territory of one or both of the Parties exclusively from originating materials; or,
- other particular circumstances as set out in Protocol 2.

4. Standards

4.1 Technical barriers to trade

The rights and obligations of the Parties relating to standards or technical regulations and related measures are governed by the WTO Agreement on Technical Barriers to Trade.

Each Party, upon the request of the other Party, shall provide information on particular individual cases of standards, technical regulations and related issues.

With the aim to reduce technical barriers to trade, the Parties may conclude an Agreement for mutual recognition in the field of conformity assessment, in the spirit of the recommendations of the WTO Agreement on Technical Barriers to Trade.

4.2 Sanitary and phytosanitary measures

The Parties shall apply their regulations in veterinary, plant health and health matters in a non-discriminatory fashion and shall not introduce any new measures that have effect of unduly obstructing trade in accordance with the provisions of the GATT 1994 and the other relevant WTO Agreements.

5. Safeguards

Article 18 provides for the application of general safeguard measures by a Party where any product is imported in such quantities and under such conditions as to cause or threaten to cause:

- serious injury to domestic producers of like or directly competitive products in the territory of the importing Party; or
- serious disturbance in any sector of the economy or difficulties which could bring about serious deterioration in the economic situation of a region.

In case of balance of payments difficulties, Article 25 of the Agreement gives the Parties the right of adopting restrictive measures in accordance with the conditions laid down within the framework of GATT 1994 and with the relevant Articles of Agreement of the International Monetary Fund.

Article 21 of the Agreement establishes the procedures for the application of safeguard measures between the Parties in case of dumping (Article 17), emergency action on imports of particular products (Article 18), re-export and serious shortage (Article 19).

6. Anti-Dumping and Countervailing Measures

Article 17 of the Agreement states that if a Party finds that dumping is taking place in trade with the other Party within the meaning of Article VI of the WTO/GATT, it may take appropriate measures against this practice in accordance with Article VI of the WTO/GATT 1994 and with the rules established by agreements, under the conditions and in accordance with the procedures laid down in Article 21. Through this Article the conformity with WTO/GATT 1994 rules has been provided.

7. Subsidies and State-aid

The Agreement evaluates "State-aid" issue in the context of distortion of competition.

According to Article 24 of the Agreement, the Parties will ensure transparency in the area of State-aid.

Against the improper practices of a Party, Article 24 of the Agreement establishes the right of the other Party to take appropriate measures.

8. Sector-specific provisions

8.1 Agriculture

The conditions of concessions in trade on agricultural products and agricultural policies between the Parties are laid down in Chapter II of the Agreement.

8.2 Services

Turkey and Macedonia agreed to cooperate with the aim of achieving gradual liberalization and mutual opening of markets for investments and trade in services, taking into account the relevant WTO provisions.

9. Other

9.1 <u>Cooperation in Customs Administration</u>

A framework was established for cooperation in customs administration with Article 22 and Protocol 2 on the definition of the concept of "originating products" and methods of administrative cooperation between the Parties.

9.2 State Monopolies

Under Article 20 of the Agreement, the Parties agreed to adjust progressively any state monopoly of a commercial character so as to ensure no discrimination regarding the conditions under which goods are procured and marketed exists between the nationals of the Parties.

9.3 <u>Internal Taxation</u>

Any measure or practice of an internal fiscal nature establishing discrimination between the products originating in the Parties has been prohibited with Article 14. This Article also prohibits repayment of internal taxation in excess of the amount of indirect or direct taxes on exports.

9.4 Protection of Intellectual Industrial and Commercial Property

The protection of intellectual industrial and commercial property is addressed in Article 26. In this Article, the Parties envisage the protection of intellectual, industrial and commercial property rights in line with the highest international standards.

9.5 Payments

According to the Article 23, any settlement and payment arising from trade of goods, services and rights to non material goods between the Parties shall be made in convertible currency, in accordance with the respective legislation of the Parties.

9.6 Public Procurement

The Parties consider the liberalization of their respective public procurement markets as an objective of this Agreement. The Parties also agreed upon granting each other's companies access to contract award procedures a treatment no less favorable than that accorded to companies of any other country.

III. GENERAL PROVISIONS OF THE AGREEMENT

1. Exceptions and Reservations

All customs duties and charges having equivalent effect on imports applied to industrial products, except for those classified as sensitive, are abolished with the entry into force of the Agreement. As for the sensitive products, customs duties and charges having equivalent effect will be gradually eliminated by the year 2008. This, however, will not preclude prohibitions or restrictions on imports, exports or goods in transit justified on grounds of public morality, public policy or public security; the protection of health and life of humans, animals or plants; the protection of national treasures possessing artistic, historic or archaeological value; or the protection of intellectual industrial and commercial property.

The Agreement allows the Parties to take measures, with concerns of security, in the cases specified in Article 31.

2. Accession

There is no provision in the Agreement allowing other countries to accede to the free trade area.

3. Dispute Settlement Procedures

A Joint Committee which is responsible for the administration of the Agreement and its proper implementation has the authority to take decisions on issues mentioned in various Articles of the Agreement. In the procedure for application of safeguard measures relating to "Dumping", "Emergency Action on Imports of Particular Products" and "Re-export and Serious Shortage" the Joint Committee has also commissioned actively as a competent authority in Article 21 of the Agreement.

4. Relation with Other Trade Agreements

Regarding "basic duties" defined in Article 2, the Agreement envisages that any tariff reduction resulting from the tariff agreement concluded as a result of the WTO/GATT Uruguay Round or accession of Macedonia to the WTO and Turkey-EC Customs Union or reductions applied by Macedonia to the products originating in the EC replaces the former basic duty.

The Agreement stipulates that rights and obligations relating to certain matters namely antidumping measures, balance of payment difficulties and state aid shall be governed by the relevant WTO Agreements.

The Agreement stipulates that measures concerning current payments connected with the movement of goods and rules on balance of payment difficulties shall be in conformity with the Articles of the Agreement of International Monetary Fund.

5. Institutional Framework

The Agreement establishes a Joint Committee which is responsible for administration of the Agreement and shall meet once a year to monitor the implementation of it.
